Terms of Use

By accessing and using this website www.tellyo.com (the "Site") you agree to and shall be bound by the following terms ("Terms").

References in these Terms to Tellyo are to Tellyo Oy a company registered in the Finland under company number 2452347-1.

1. Definitions

"Agreement" means the Software as a Services Agreement signed between you and Tellyo.

"AUP" means Tellyo's Acceptable Use Policy accessible at https://tellyo.com/assets/legal/Tellyo_Terms_of_Use.pdf to which You are bound.

"Content" means all and any video and audio materials including but not limited to text, images, logo, artwork, graphics, pictures, advertisements, sound and any intellectual property contained in the materials uploaded by You to Your User Account in the use of the Services.

"Demo Account" means a provisional account provided to you to test the Services for a temporary period.

"Services" means the professional business to business Tellyo Pro services for You to ingest, edit and share video content to all social media channels and all other services provided to You by Tellyo.

"User Account" means the Tellyo account issued to You under the Agreement which contains Your profile and allows you to manage the Content.

"You" and/or "Your" means means the individual, corporation or other entity that (i) has entered into an Agreement, (ii) has received a Demo Account/User Account through Tellyo, and/or (iii) otherwise uses Tellyo's website and/or the Services or any portion thereof.
